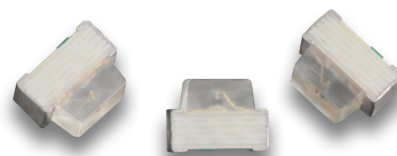

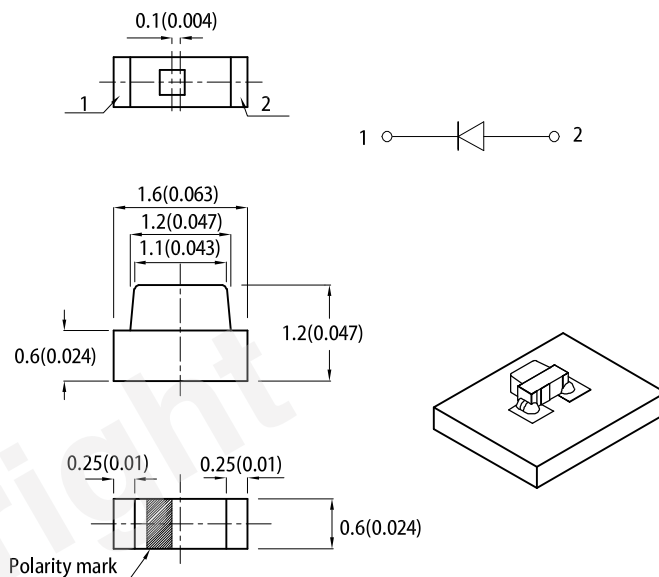

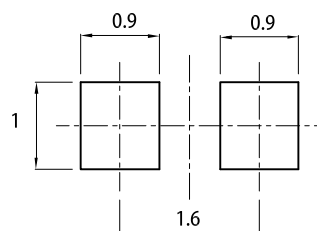


PACKAGE DIMENSIONS

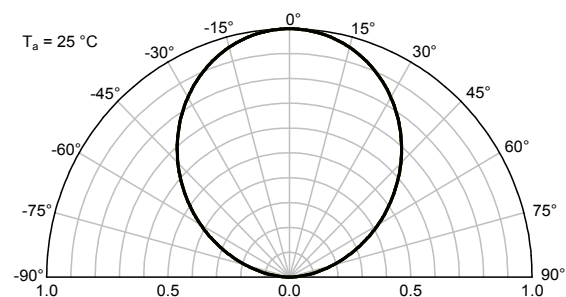

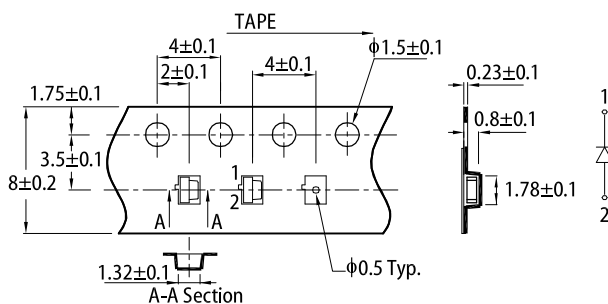
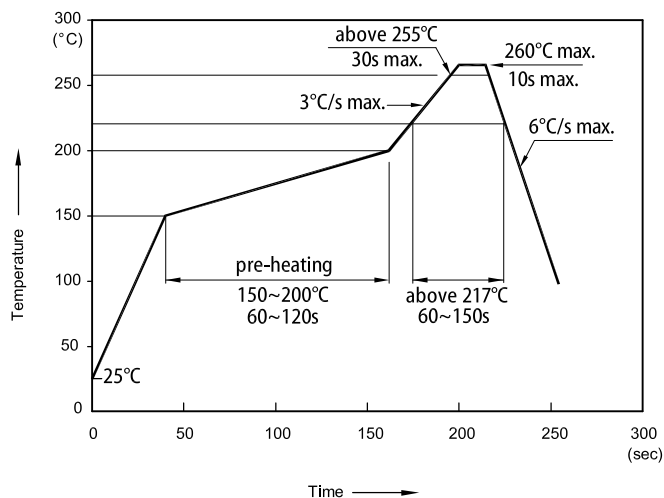
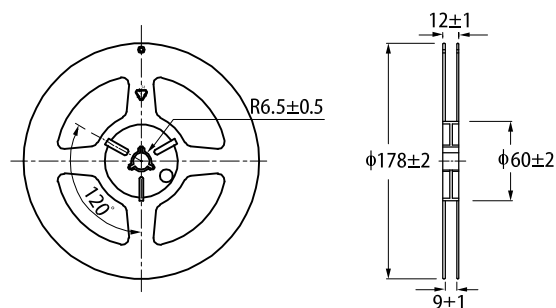
Ambient temperature ($^{\circ}\text{C}$)

Ambient temperature ($^{\circ}\text{C}$)

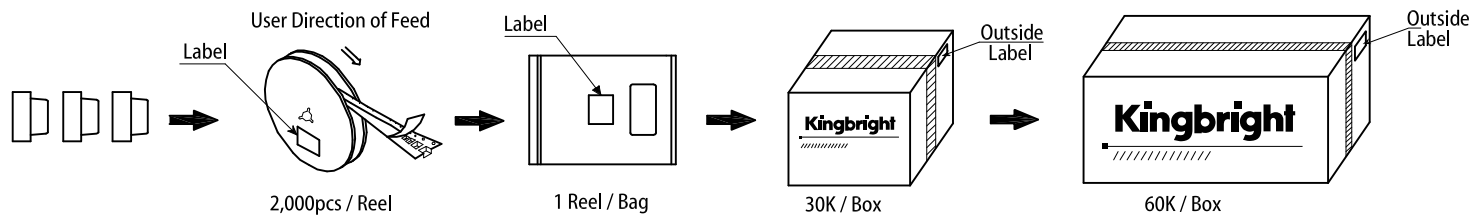
